**Schedule of the recruitment procedure for the IEDS for the academic year 2024/2025
for the position of a doctoral student in the project "Topological Methods in Medical Diagnosis"
(research grant 101120290 — GAP — HORIZON-MSCA-2022-DN-01) implemented by the
Mathematical Institute of the Polish Academy of Sciences**

1. 24 May 2024 — opening of registration in the online candidate registration system (IRK).
2. 6 June 2024 – closing of the registration of candidates in IRK, up to this date the candidate must create an account in the IRK online recruitment system, pay the recruitment fee (the date of transfer is decisive) and enter the required information and documents.
3. 7 June 2024 – notifying candidates to the e-mail addresses provided in the IRK system of the date and place of interviews.
4. 10 June 2024 – interviews with candidates.
5. 11 June 2024 – notifying candidates about results of the recruitment.
6. 12-14 June 2024 – submitting the required documents by candidates qualified for admission and enrolment on the list of PhD students.
7. 17 June 2024 – notifying candidates on the reserve list about their eligibility for admission.
8. 18-21 June 2024 – submitting the required documents from candidates qualified for admission by the reserve list and enrolment on the list of PhD students.
9. 13 September 2024 – deadline for publication of the results of the admission procedure on the IEDS website.
