Resolution No 13/2023
of the Council of International Environmental Doctoral School associated with the Centre for Polar Studies at the University of Silesia in Katowice (IEDS)
of 14th March 2024
on the schedule of mid-term evaluation in the academic year 2023/2024

Pursuant to Section. 3(1) of Annex 3 to the Resolution no. 258 of the Senate of the University of Silesia in Katowice of April 26, 2022, regarding specifying the Regulations of the International Environmental Doctoral School associated with the Centre for Polar Studies at the University of Silesia in Katowice (IEDS), the IEDS Council adopts the schedule of mid-term evaluation in the academic year 2023/2024:

1

The mid-term evaluation in the International Environmental Doctoral School associated with the Centre for Polar Studies at the University of Silesia in Katowice in the academic year 2023/2024 will be held in the period from June 17, 2024, to September 30, 2024, with the reservation that:

1. The deadline for submitting the report on the implementation of the Individual Research Plan (IRP) will be at least two weeks before the scheduled date of the open scientific seminar, during which the doctoral student will present the progress in the implementation of the IRP and the status of the doctoral project, but no later than August 31, 2024.
2. The dates, manner and place of conducting open scientific seminars, during which doctoral students will present progress in the implementation of the IRP and the status of the doctoral project, will be made public via the IEDS website.
3. Open scientific seminars referred to in Section 1(2) may be carried out:
 - 1) at the headquarter of the IEDS Entity (stationary mode);
 - 2) using electronic means of communication, ensuring, in particular, real-time transmission of the seminar between its participants and real-time multilateral communication, enabling participants of the seminar to speak - while maintaining the necessary security procedures (remote mode);
 - 3) at the headquarter of the IEDS Entity with the simultaneous transmission of the course of the seminar in real time, using electronic means of communication, for participants of the seminar staying outside the premises, in a way that ensures multilateral communication in

real-time, during which participants of the seminar can speak - while maintaining the necessary safety procedures (hybrid mode).

- 4) Meetings of the mid-term evaluation committee will take place on the day of the seminar or the following day.
